


**60 PERCENT METHOD OF ANNEXATION
PETITION REQUESTING ANNEXATION**

To the Mayor and Council of the City of Brookhaven, Georgia.

1. We, the undersigned, representing not less than 60 percent of the electors resident in the territory described herein and the owners of not less than 60 percent of the real property within the territory described herein, do respectfully request that the City Council of the City of Brookhaven, Georgia, annex the territory described below to the City of Brookhaven, Georgia, said City having a population of 200 or more persons, and extend the city boundaries to include the same.

2. The territory to be annexed is unincorporated and contiguous (as described in O.C.G.A. § 36-36-31) to the existing corporate limits of the City of Brookhaven, Georgia, and the description of such territory is as follows:

Total Number of Land Parcels: 113. Land surveys and details attached to this application.

- d) 1705 and 1721 Woodcliff Drive NE (single family homes - 2 parcels – zoned R-85)



Parcels Combined





Woodcliff Annexation Map







DeKalb County, GA Tax Parcel Map


Land Owners and Elector Signatures:

The signature process was completed via a signed, notarized, paper ballot, requiring all land owners and/or electors, to vote YES or NO to annexation. Ballots were accepted between July 9, 2016 and August 30, 2016. All signed, notarized ballots are attached to this application. Final voting results exceed 60% annexation requirement.
